Addendum To Associate Membership Application

Please read this section to assist you in understanding the ACKCSC, Inc. application process and the length of time it takes to process and vote on an application. It can take six months or more to go through the process and be voted on. Please answer application questions in as much detail as possible. If you need more room, feel free to attach additional sheets. Applications submitted on outdated forms will be returned to the applicant. Please check our web site, www.ACKCSC.org for the most current application forms.

The ACKCSC, Inc. is the American Kennel Club (AKC) Parent Club for Cavalier King Charles Spaniels in America and is an AKC Member Club which operates under the auspices of the AKC. Therefore, show/club experience of the applicant should reflect his/her affiliation with AKC recognized organizations/events only.

APPLICATION PROCESS

1. Your application is received by the Corresponding Secretary who makes sure it is complete. **Note: *Incomplete membership applications will be returned to the applicant, along with their check for dues.***
2. Your application is sent to the Membership Committee, which is comprised of a chairman who is a member of the Board, and three non-Board members. **Note: *The Membership Committee will not contact you directly. If they have questions about your application, they will contact your sponsor(s). If your sponsor(s) fail to answer any Membership Committee questions promptly, your application may take longer to process.***
3. Your name, and the names of your sponsors, are printed in the ACKCSC, Inc. Newsletter (The Royal Dispatch) which is published four times a year. Members have 30 days to send their comments, if any, to the Membership Committee.
4. Once the Membership Committee reviews the application and satisfies any questions, they notify the Chairman of the Membership Committee of their recommendations.
5. At the direction of the Chairman of the Membership Committee, the Corresponding Secretary prepares a ballot and sends it along with the application, to all ACKCSC, Inc. Officers and Board members for a vote
6. When the Corresponding Secretary receives all of the returned ballots, the secret security envelopes are removed from the mailing envelopes. They are mixed up, opened, and counted. When voting by mail ALL ballots must be returned and 2/3 favorable majority is required for election to membership.
7. The Corresponding Secretary notifies the Officers and Board Members of the ballot results and sends a letter of acceptance or denial to each applicant. **Note: *Should the application be denied, the ACKCSC, Inc. is under no obligation to make known the reasons. Cashing of the applicant's check does not indicate approval for membership. If an applicant is not elected to membership, the dues amount will be refunded. ACKCSC, Inc. recommends that applicants retain a copy of the completed application forms.***
